#### 1. INVITATION

1.1 Gauteng Tourism Authority hereby requests a suitable service provider to submit formal quotations assist GTA to facilitate the strategic session for Ga-Rankuwa Hotel school for a period of two (2) days in March 2023 as well as to develop a strategy for ameliorating the operation of the Ga-Rankuwa Hotel School.

#### 2. BACKGROUND

2.1 The Ga-Rankuwa Hotel School was Established in 1972, the Ga-Rankuwa Hotel School (GHS) offer one-year Certificates and two-year Diplomas in food preparation. In addition, the school offer short courses in hospitality. Historically, the school was under the Northwest Province and was in September 2013 transferred to Gauteng under the administration of GTA. The objective of the Ga-Rankuwa Hotel School Ameliorating Strategy to create a business case that addressed the need of tourism and hospitality skills and to create a roadmap for optimal utilisation of the school thereby developing a strategic plan and its annual performance plan.

- 2.1. Well-defined chronological sequence of activities involved in executing the scope of work outlined in this TORs document.
- 2.2. All these activities must have completion dates.
- 3. This aspect of the methodology carries a total of 40 points. If a bidder meets all three requirements as set out in the bullet points above (2.1. 2.2) a full score will be given. 2.1. worth 30 points, 2.2. worth 10 points,
- 4. The service provider must demonstrate their understanding in Strategy Development and Regeneration, Strategic Planning, Education/ Training field, and Tourism and Hospitality.
- 5. The maximum points a bidder can score in this sub-section is 40 points

A bidder is expected scores to score 65 points and above. A bidder that fails to obtain at least 65 points will not be considered for further evaluation in stage 2 (Price and BBBEE).

#### 7.2 Criteria for evaluation are as follows:

- a) The service provider will be appointed in terms of the Preferential Procurement Regulations (2022).
- b) The proposal will be evaluated using the 80/20 preferential system wherein 80 represents price and 20 for specific goals.

### 1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:

#### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
