1. INTRODUCTION

1.1. The Purpose of the Terms of Reference

I. Appointment of a service provider to assist GTA in mapping processes and procedure manuals for organizational policies.

1.2. The Aim Process Mapping

- i. Stimulate the culture of using processes to drive service deliver.
- ii. Assist Business Units in identifying processes that should be mapped or re-engineered.
- iii. Identify areas for process automation.

1.3. The Objectives of Process Mapping project

- i. Develop a model for business operation.
- ii. Create a common understanding for the new business model.
- iii. Documented processes.
- iv. Assist the organisation in identifying processes that must be automated.
- v. Assist the organisation in identifying processes that must be integrated to enable seamlessness.

2. RATIONALE

- 2.1 The Gauteng Tourism Act (No. 10 of 2001), Section 3 provides for the establishment of the Gauteng Tourism Authority (GTA). Section 4 of the same Act provides for powers and duties of the Authority. The Act aims to provide for the promotion and sustainable development of tourism in Gauteng. The Authority derived its legislative mandate from the Gauteng Tourism Act, as amended by Act No. 3 of 2006. The rationale for revising this Act is to reflect the specific marketing role of the GTA, which was a newly adopted mandate, to include other developments, such as the implications of the National Tourism Act, No. 3 of 2014.
- 2.2 GTA is an implementing agency of the Gauteng Department of Economic Development (GDED). GDED approves the mandate and provides clarity on the roles and responsibilities of GTA. The Authority operates within the parameters of certain regulations. The declaration of government policies is derived from the Constitution of the country. The Constitution of the Republic of South Africa (Act No. 108 of 1996) outlines the roles and responsibilities of national, provincial and local governments, providing the basis on which these are regulated in all spheres of activities. GTA was established in terms of the Gauteng Tourism Act, No. 18 of 1998. The Act aims to provide for the promotion and sustainable development of tourism in Gauteng. Thus, the Authority derived its legislative mandate from the Act above.

3. PROBLEM STATEMENT

- 3.1 GTA developed a business strategy with an objective of improving the operations of the organisation. The objective of the strategy was to address challenges facing the organisation in terms of back-office systems and processes. Part of the strategy's implementation plan is the development of process map or re-engineering the existing and subsequently automate them. The project should be implemented in a wholistic approach which involve the assessment of the existing systems and processes to avoid duplication of efforts and lack of integrations of processes and systems.
- 3.2 Over and above the business strategy, GTA developed a sustainability strategy to address the current funding model. The implementation of the strategy demanded the system development and automation of processes.

- 4.1 Process need assessment report.
- 4.2 Documented Business Processes with their procedure manuals.
- 4.3 Recommendation Report for Process Automation.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
