## **1. INVITATION**

- 1.1 This is a Request for Quotation to service providers, with relevant and appropriate travel logistics expertise are invited to submit proposals to Gauteng Tourism Authority (GTA) for speaker's flights, learners and speaker's accommodation, arrangement of the hosting National Tourism Career Expo 2023 from the 29 September-01 October 202301 August 2023.

## **2. BACKGROUND**

- 2.1 NTCE is an initiative of the Department of Tourism and the Culture, Arts, Hospitality and Sports Sector Education and Training (CATHSSETA). Initiated to create opportunities for tourism diversification and harnessing local skills for livelihood prospects looking at trade, tourism, or cultural hubs. GTA submitted a competitive bid to bring this event to Gauteng and thus, it was awarded to the destination. This event will be hosted in the province for the successive three years (2021 – 2023). NTCE 2023 will be the final instalment of the three events that were awarded to Gauteng

## **3. PROBLEM STATEMENT**

- 3.1 NTCE partners need flights and to accommodate the exhibition speakers and learners from other 8 Province who will be attending the NTCE in Johannesburg. Therefore, a need arises to source and appoint a service provider to secure flights and accommodation for the speakers and learners during the of the National Tourism Career Expo 2023, scheduled from the 29<sup>th</sup> of September to 1<sup>st</sup> of October 2023 at the Johannesburg Expo Centre.

## **4. FORMAL PRICE QUOTATION**

- 4.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.
- 4.2 The payment process be in accordance with the GTA procurement process, and its conditions will be discussed with the appointed service provider. A service level agreement will be signed between the service provider and the GTA.

## 5. DELIVERABLES/SPECIFICATION

5.1 The appointed service provider will be responsible for providing flights and accommodation services as follows:

- **Accommodation for 15 speakers from 9 Provinces for 3 nights (15 rooms Dinner bed and breakfast (28<sup>th</sup> of September - 1<sup>st</sup> of October 2023) DBB.** 29<sup>th</sup> of September 2023 – Only Bed and Breakfast. 3 Star in Braamfontein, Auckland Park, Gold Reef City.
- **Accommodation for learners – 140 learners for 1 nights (70 Sharing rooms- with dinner bed and breakfast.** 3 Star in Braamfontein, Auckland Park, Gold Reef City. The 70 rooms will be distributed over 3 nights **(28<sup>th</sup> of September – 1<sup>st</sup> of October 2023). 1 night of the 3 nights for both learners and educators.**
- **Accommodation for 20 educators for 1 night (20 rooms- with dinner bed and breakfast). DBB.** 3 Star in Braamfontein, Auckland Park, Gold Reef City. The 20 rooms will be distributed over 3 nights **(28<sup>th</sup> of September – 1<sup>st</sup> of October 2023).**
- **12 Adjudicators – One night (12 rooms- BB). 30 September – Same hotel as the Speakers** Only Bed and Breakfast. 2- 3 Star hotel in Braamfontein, Auckland Park, Gold Reef City. **1 night on the 30<sup>th</sup> of September 2023.**
- **10 Flights for speakers (Economy Class - Arrival 28<sup>th</sup> of September in Jhb; Departure 01<sup>st</sup> of October and flights).** The flights will be speakers from (3 x Cape Town, 2 x Durban, 1x Drakensburg, 1x East London, 2 X Gqeberha(PE), 1x Free state).

1.2 **To be completed by the organ of state**

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
