- 1.1 The Gauteng Tourism Authority (GTA) hereby invites suitable service providers to submit formal quotations for the provision of Garden Services for Ga-Rankuwa Hotel School for a period of six (6) months.
- 1.2 Service provider must demonstrate the relevant expertise in providing required service for garden services. The project requires an experience service provider capable of garden services expertise who will work well with the Ga-Rankuwa Hotel School team.

- 2.7 Clean at the back of the building 40 meters and the rest once a month.
- 2.8 Clean and sweep paving in front and all paving around the building.
- 2.9 Cut and trim all flowers and trees around the building.
- 2.10 Pick-up papers, water grass and flowers.
- 2.11 Cutting of reeds at back-yard.
- 2.12 Fertilizers lawn (lawn dressing).
- 2.13 Weed control with environmentally friendly chemicals.
- 2.14 Pruning and trimming.
- 2.15 Sweeping the front area from packing lot.
- 2.16 Remove the weeds and the grass on paving.
- 2.17 Treat the paving with chemicals to kill the weeds and grass.
- 2.18 Remove dry branches, trim and water the tree.

 - (e) forward the matter for criminal prosecution, if deemed necessary.
