1. INVITATION

- 1.1 Gauteng Tourism Authority hereby requests suitable service provider with appropriate skills and experience to submit quotations to conduct First Aid Level 1 and Level 2 Training for 100 tourism products in Gauteng. 20 individuals per region: Joburg, Ekurhuleni, West Rand, Sedibeng and Tshwane. The First Aid training should be HWSETA accredited.

2. BACKGROUND

- 2.1 In South Africa, tourist guiding is a regulated profession governed by national legislation. One of the requirements for an individual to be registered as a Tourist Guide is to undergo SAQA registered formal training. First aid training is one of the required qualifications and the first aid certificate is valid for three years thereafter Guides should do a refresher course, a person that would like to become a tourist guide must undergo training as part of a formal qualification registered by the South African Qualifications Authority (SAQA).

3. FORMAL PRICE QUOTATION

- 3.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.

4. DELIVERABLES/SPECIFICATIONS

- 4.1 The service provider will be required to deliver the following:
- 4.1.1 Suitable service provider with appropriate skills and experience to submit proposals to conduct First Aid Training for 100 Gauteng tourism products (20 per region) in the financial year 2024/25. The first aid course should be HWSETA accredited. Approved under the General Safety Regulations, of the Occupational Health and Safety Act.
- 4.1.2 Accredited First Aid Level 1 and 2 Training. The training will be held in the learner's respective regions: Tshwane, Joburg, West Rand, Sedibeng, and Ekurhuleni.
- 4.1.3 The training is for 3 days per region.**
- 4.1.4 **Please note that the service provider will be responsible for catering in all 5 regions.**
Lunch : Two different starches, two different proteins, two salads, 1 bottle of water and one cold drink per person.
- 4.1.5 GTA will provide the venue for training.
- 4.1.6 **The SETA accredited training programme should cover the following aspects of First Aid:**
- ✓ Demonstrate an understanding of emergency scene management.

- ✓ Demonstrate an understanding of elements of anatomy and physiology.
- ✓ Assess an emergency situation.
- ✓ Apply first aid procedures to a life-threatening situation.
- ✓ Treat common injuries.
- ✓ Demonstrate the principles of primary emergency care.
- ✓ Sustain a basic level of preparedness for health emergencies.
- ✓ Assess and manage an emergency life support for adults, children and infants according to current international protocols.
- ✓ Explain and manage shock.
- ✓ Keep records of incident/accident.
- ✓ Covid Protocols.
- ✓ The ideal service provider(s) should have experience in implementing the elements listed above.

- f) The GTA reserves the right **NOT** to make an appointment for this project.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 **To be completed by the organ of state**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
