## **1. INVITATION**

- 1.1 Gauteng Tourism Authority intends to appoint a service provider with suitable skills and experience to design and construct the exhibition stand for the realisation of the Gauteng Pavilion at the Meetings Africa 2025 to be held at the Sandton Convention Centre 24-26 February.

## **2. ABOUT GAUTENG TOURISM AUTHORITY**

- 2.1 GTA is mandated to develop, promote, coordinate and facilitate responsible and sustainable tourism in the Gauteng Global City Region, and to create a world-class destination that attract business visitors and all other tourists to the province, benefit the community and contribute to job creation and economic growth.
- 2.2 The entity's strategic goals are to create and promote a world-class tourist destination; contribute towards tourism sector industry development; facilitate industry coordination and cooperative governance. GTA is further mandated to foster a responsible and sustainable tourism industry and implement progressive corporate governance practices.

## **3. OVERVIEW**

- 3.1 Meetings Africa is a Business Events Trade Show, owned by South African Tourism, with the specific objective of creating a market access platform, for African Business Events Products. It serves as the primary platform to enable the growth of the business events industry on the continent and ultimately contributes towards its economic growth.
- 3.2 Meetings Africa is a 2-day trade show with a dedicated Educational Day which is executed in conjunction with the key global, continental and national industry associations. It exists to provide a platform for exhibitors to showcase their offerings to International and local buyers, African associations and corporate planners. It is the most formidable platform on the continent for you to meet face-to-face with the most influential buyers in the world, and to be part of Africa's growth.
- 3.3 Venue
- Sandton Convention Centre (SCC)

## **4. FORMAL PRICE QUOTATION**

- 4.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.

## 5. DELIVERABLES/SPECIFICATIONS

Main scope of the project is to design and build a functional **shell scheme** based exhibition stand for Gauteng Tourism Authority. Construction of the stand must be in accordance with the regulations set by the organisers.

It is the responsibility of the appointed service provider to take all measures set out by the event organisers on all compliance.

In addition, the scope of work shall include a complete construction and handover of the finished stand 24 hours before the opening time of the show, allowing sufficient time for GTA to get ready for work.

On appointment, the appointed service provider must draft a service level agreement between themselves and GTA. The service provider is also expected to submit a close-out report post the event.

### Stand Reception

One reception desk should be installed at prominent spot facing the main passage of the hall suitably finished to match the rest of the GTA stand design (refer to the attached floor plan)

- One reception counter with shelves and two lockable drawers

- Gauteng logo in front of the main reception counter (luminated)
- Furniture: 2 adjustable chairs for the receptionists
- Two electric plug points with X2USB ports for charging
- Must have x2 ultra–Large TV 86-inch by the reception counter

### **Displays**

- The stand must be predominantly built from shell scheme
- The appointed service provider is welcomed to share ideas with GTA on optional exhibition stand layout
- The appointed service provider is required to make provision of static display ribbon board to be placed all around the top of the stand to afford GTA a platform to display more images and messages
- Production of big images on light boxes (A0+)
- Application of X3 QR codes embedded on the stand (no stickers)

### **Additional Services**

- Securing X60 food vouchers per day – TOTAL value R200
- Securing of X6 flat rate venue parking tickets per day = total 60

### **Co-exhibitor space/booth**

The GTA stand should be in such a way that it provides exhibitor booths for a maximum of 8 co-exhibitors. This must comprise a table, two chairs for visitors, one chair for host per each co-exhibitor

- This space is allocated to 8 co-exhibitors and is within the Gauteng stand
- Must have a logo and product name
- Lockable cabinet
- A plug point per station
- USB charger per station
- No high-chairs for co-exhibitors

### **Meeting area**

The appointed service provider must reserve a space for meetings for the CEO and Senior managers. This forms part of the Gauteng Tourism pavilion.

- The stand must have a boardroom with table and x2 2-seater couches to accommodate 6 people.
- Must have a branded tablecloth.
- Should include electric plug points and USB charging ports.
- Branded walls from the inside.

### **10 SMMEs allocation on the stand:**

The service provider will be required to deliver the following for SMMEs:

- Aluminium Structure (Shell Scheme) with slatted wooden walls as dividers of the stands.
- Lighting, USB charging port and plug point per SMME stand.
- 3m x 2m stand for 2x sharers.
- 3 shelves each to display their products.
- 2 chairs and 1 table per stand (café table or cocktail table with bar stool).
- Full graphic in the middle and colour graphic on each side of the stand (GTA marketing branding)
- All furniture, including lockable credenza's and display plinths must be of a superior quality.

### **General Stand Concept and Design**

The following general considerations are important and should be borne in mind when preparing the design proposals.

### **Visibility of the stand**

It is important that the Gauteng stand stands out amongst competitor exhibitors and be visible from far within the hall in which exhibitors will be accommodated. The appointed service provider must produce and install a Circle Hanging Structure, and this feature must be placed high above the exhibition stand with lighting.

### **Look and Feel of the design**

The look and feel of the stand must be in line with the GTA CI, and should be world class and result in delegates being drawn to the stand.

### **Platform & Flooring**

The entire GTA stand must be raised onto a wooden platform with backlit sides and aluminium side skirting. All areas will have laminated flooring, and elevation must be in accordance with event regulations.

All furniture, including lockable credenza's and display plinths must be of a superior quality.

### **Storage Area**

The service provider must provide a lockable storage room within the stand

Dimensions: 3mX2m

- a) The service provider will be appointed in terms of the Preferential Procurement Regulations (2022).
- b) The proposal will be evaluated using the 80/20 preferential system wherein 80 represents price and 20 for specific goals.

- c) The GTA reserves the right not to appoint any service provider if the received proposals do not match its requirements.
- d) Service providers may ask for clarification via email on these terms of reference or any of its annexures up to 48 hours before the deadline for the submission of the bids.

- f) The GTA reserves the right **NOT** to make an appointment for this project.

- i) A service level agreement will be signed between the service provider and the GTA.

**1.2 To be completed by the organ of state**

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

**1.4 To be completed by the organ of state:**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. **FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT**

3.2.1. **POINTS AWARDED FOR PRICE**

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left( 1 + \frac{Pt - Pmax}{Pmax} \right) \text{ or } Ps = 90 \left( 1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where

- Ps = Points scored for price of tender under consideration  
Pt = Price of tender under consideration  
Pmax = Price of highest acceptable tender

4. **POINTS AWARDED FOR SPECIFIC GOALS**

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

  - (e) forward the matter for criminal prosecution, if deemed necessary.
