1. INVITATION

- 1.1 Gauteng Tourism Authority hereby requests a suitable service provider with appropriate skills and accreditation to submit proposals to provide a **NQF Level 2** Culture Site Guiding full qualifications as well as Recognition of Prior Learning for the same qualification in Gauteng.

2. BACKGROUND

- 2.1 In South Africa, tourist guiding is a regulated profession governed by national legislation. One of the requirements for an individual to be registered as a Tourist Guide is to undergo SAQA registered formal training. This is training for individuals working as Tour Guides at different tourism attractions and sites, albeit not having the requisite qualifications and without the qualifications they cannot be registered by GTA as Tour Guides. The GTA as the Gauteng Provincial Registrar encourages compliance with the Tourism Act.

3. FORMAL PRICE QUOTATION

- 3.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.

4. DELIVERABLES/SPECIFICATIONS

- 4.1 The service provider will be required to deliver the following:

Suitable service provider with appropriate skills and experience and accreditation, to submit proposals to train individuals on the Culture Site Guides full course as well as Recognition of Prior Learning for the same qualification, for 25 (see details below) individuals in Gauteng. The qualification should be CATHSSETA accredited.

1. Culture Site Guiding Training – CATHSSETA Accredited Full Course – NQF Level 2
 - a) **15** learners per class in Joburg.
 - b) **10** learners per class in Tshwane, the dates (classes) do not need to be exclusively for the individuals from GTA.
 - c) **Learners have potential to be assessed for RPL**
 - d) Catering lunch (two different proteins, one starch and two salads, one drink juice or cold drink can), breakfast (tea & coffee and sandwiches & scones) & water for face-to-face classes.
 - e) Training venues will be provided by GTA
2. Responsible for all the processes that leads to the qualification.
3. Certification of the Learners.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.1. POINTS AWARDED FOR PRICE

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
