1.2 Gauteng Tourism Authority (GTA) hereby invites an Accredited Service Providers to submit proposals to (GTA) to conduct a 3-day Reception Skills Training Program targeting Unemployed Youth and Front-line Staff/Receptionists around Tshwane, Ekurhuleni, Joburg, Sedibeng and West Rand and its surrounding areas and to deliver the following.

- Transportation for three (03) officials throughout the training sessions across all five Regions:
 - Sedibeng District
 - West Rand District
 - City of Ekurhuleni
 - City of Johannesburg
 - City of Tshwane

2. BACKGROUND

- 2.1 Tourism and Hospitality SMMEs, as well as unemployed youth, play a crucial role in the country's economy; therefore, the Regional Skills Customer Service Excellence training will be part of sector rejuvenation interventions. Reception Skills include skills that can range from customer service to being detail-oriented, and they may vary based on specific reception duties and place of employment.
- 2.2 Reception Skills Training: This training equips students with essential skills to provide excellent service in various settings, including guest houses, hotels, and organizations requiring administrative support.
- 2.3 The skills and knowledge deficit are a major barrier to growth and development in the township economy as much as in the community of Tshwane / Ekurhuleni. Many individuals in these communities lack the necessary education, training, and mentorship to capitalise on economic opportunities and create sustainable businesses. This means that education is still the key to these young people's prospects improving in the South African labour market. Youths become even more vulnerable to unemployment if they are not equipped with the skills needed for the future of work.
- 2.4 There is a large discrepancy between what the youths are being taught and what employers expect them to know. This is why tourism industry has an enduring commitment to prepare young people and made skills development a priority to seal all gaps identified.
- 2.5 **Some key factors and outcomes to be included in the scope of Reception skills should focus on:**
- Theory Session
 - Switch Board Simulation / Practical Session
 - Hygiene and Safety Standards
