1. INVITATION

- 1.1 This Request for Quotations (RFQ) is an invitation by Gauteng Tourism Authority to prospective respondents to submit quotations for the design, supply, fabrication delivery and installation of twenty (20) Tourism Brown Signages within all four (4) Gauteng city regions. The project should be completed within a period of **60 (sixty) Days** upon appointment.

2. BACKGROUND

- 2.1 The Gauteng Tourism Authority aims to enhance visibility and heritage sites through The Fabrication (Manufacturing, Delivery) and Installation of Gauteng City Regional Tourism Brown directional signage. This initiative supports local tourism development and assists visitors in navigating sufficient historical and cultural landmarks within the region.

3. FORMAL PRICE QUOTATION

- 3.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project. No additional cost must be included after awarding.

4. DELIVERABLES/SPECIFICATIONS

- 4.1 The appointed service provider will be responsible for the Design, supply, fabrication (Manufacturing, supply and Delivery) installation of double-sided brown tourism signage for Gauteng City Regional Tourism according to the following specifications:

DESCRIPTION
Design, supply, fabrication (Manufacturing), delivery and installations Specifications: ● Material: Signs shall be constructed from sheet chromatic or similar approved material, with a minimum thickness of 1.4mm. ● Frame: A frame galvanized of 25mm square tube steel, with a minimum thickness of 2.0mm, shall be riveted to the sign face. ● Sign Face Dimensions: Signs with a length of less than 2450mm and a height of less than 1225mm shall be manufactured from a single sheet. The overall size of the signs must comply with South African Road Traffic Signs Manual. ● Power Coating: Frames shall be powder coated Seal Grey EPU38. ● Riveting: Spacing between rivets shall not exceed 150mm. Rivet heads shall be painted in the same color as the sign face color where they are located.

- **Sign Face Color & Material:** Signs shall be brown and made from engineering grade (Class 1) retro-reflective material 3uM or a similar approved material, carrying a seven (7) years warranty.

- **Fixing:** Fixing bolts, nuts, and washers shall have a hot dip galvanized coating to comply with SAGS for 763 for coatings on Type C1 articles.

Installation Location: The provision and installation will be discussed with the appointed service provider for uploading into GIS (Geographical Information Systems)

4.2 To achieve the above, a successful bidder will be required to meet the following requirements:

- 4.2.1 The service provider(s) may not recruit or shall attempt to recruit an employee of GTA (Gauteng Tourism Authority) for the purposes of preparation of bid or for the duration or the execution of this contract or any part thereof.
- 4.2.2 Signage must be done according to Department of Tourism, Gauteng Department of Roads and Transport and Municipal standards, specifications and colours.
- 4.2.3 In an event of successful bidder becoming insolvent or unable to fulfil their contractual obligations, the GTA reserves the right to appoint a replacement, through a closed procurement process, from the remaining successful bidders.
- 4.2.4 Pricing must be firm for the duration of the contract and bidders must include all their costing for the duration of a contract.
- 4.2.5 No additional costs must be included after awarding.

N.B: Failure to provide a quotation with a breakdown of the deliverables may result in the disqualification of the bid.

- c) The GTA reserves the right not to appoint any service provider if the proposals received do not match its requirements.
- d) Service providers may ask for clarification via email on these terms of reference or any of their annexures up to 48 hours before the deadline for the submission of the bids.
- e) Any request for clarification must be submitted by email at Bids@gauteng.net and answers will be emailed to all service providers that require any clarity.
- f) The GTA reserves the right **NOT** to make an appointment for this project.
- g) The cost of preparing and submitting bids by prospective suppliers will be at the cost of the prospective supplier.

- h) The validity of the received bids shall be ninety (90) days.
- i) The awarded service provider may be required to sign a service level agreement with the GTA.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
