## **1. INTRODUCTION**

- 1.1 Gauteng Tourism Authority (GTA) is mandated to develop, promote, coordinate, and facilitate responsible and sustainable tourism in the Gauteng global city region, and to create a world-class destination that attracts visitors and all other tourists to the province to benefits the people, and contributes to job creation and economic growth.
- 1.2 The entity's strategic goals are to create and promote a world-class tourist destination; contribute towards tourism sector industry development; facilitate industry coordination and cooperative governance. GTA is further mandated to foster a responsible and sustainable tourism industry and implement progressive corporate governance practices.
- 1.3 Overall, the GTA is responsible for the development, maintenance and seeding of destination Gauteng brand and propel it to greater heights. Our primary objective is to tell and share the destination Gauteng story and mobilize all the partners behind the vision of Growing Gauteng Together 2030.

## **2. INVITATION**

- 2.1 This Request for Quotation (RFQ) is an invitation by Gauteng Tourism Authority to the service providers specializing in tour operator service to provide logistical support for media hosting programme as part of the implementation and launch of the festive summer campaign programme.

## **3. FORMAL PRICE QUOTATION**

- 3.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.

## **4. BACKGROUND**

- 4.1 The GTA will be implementing the #GPFestiveSummer Campaign. To ensure a seamless interface between the Quarter 2 activities which ended in September at the height of the Tourism Month and the Quarter 3 plans which started in October and scheduled to end in March 2026, an anchor media & PR campaign dedicated to the GP Summer Ena'Lanto with cross cutting objectives and focus areas is required.
- 4.2 Destination Marketing and Communications plans to use the Maropeng Arts and Culture Festival as a platform to officially launch the festive summer campaign in Gauteng to prompt

people to a Staycation in Gauteng this summer and festive period, for the buzz, the convenience of having many things to do, and a variety of places to visit and stay in.

## **5. DELIVERABLES/SPECIFICATIONS**

5.1 The service provider will be required to deliver the following :

Media Hosting – Festive summer campaign launch through a showcase of programmes in the Cradle of Humankind on the 29<sup>th</sup> of November 2025

- Provide full-day transport service for 20 people
- Departure from 1 Sandton Drive to Lanseria International Airport, to Kagiso, to Maropeng visitor centre and back to Sandton
- Snack pack to be provided on the transport with muffin, juice, water, a fruit and snack bar
- Beverage allowance of R5000
- Brunch for 20 people
- Attendance of the Maropeng Arts and Culture Festival
- Please ensure provision of tickets and lunch at the event

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
