1. INTRODUCTION

- 1.1 Qantas Airlines will launch its new direct route between Perth and Johannesburg on **7**th of **December**, opening an essential gateway for increased arrivals from Australia and New Zealand, two high-value long-haul markets with strong outbound travel potential and growing interest in African destinations.
- 1.2 To mark this milestone and create a memorable first impression for the visiting media and trade representatives, the Gauteng Tourism Authority (GTA) will host a cultural welcome at OR Tambo International Airport (ORTIA). GTA therefore seeks to appoint a service provider to deliver a seamless and professional welcome experience, including cultural entertainment, transport logistics, and hospitality support for the performing group.

2. INVITATION

2.1 The Gauteng Tourism Authority (GTA) is requesting a quotation from a reputable service provider to organize a group of Zulu Dancers who will welcome the Group arriving on Qantas Airlines as part of the entertainment on the 7th of December 2025 at OR Tambo International Airport.

3. FORMAL PRICE QUOTATION

3.1 The formal all-inclusive quotation (inclusive of VAT) should indicate the total costs that will be charged for the execution of the project.

4. BACGROUND

- 4.1 Qantas Airlines will be operating a special media and trade visit to South Africa in December as part of efforts to showcase destination experiences and strengthen tourism partnerships. The delegation will arrive at OR Tambo International Airport on 7 December, and the Gauteng Tourism Authority (GTA) will host a warm cultural welcome on arrival.
- 4.2 As the entry point into Gauteng and South Africa, OR Tambo International Airport is a strategic location to create a memorable first impression for the visiting media and trade representatives. To reflect the province's rich cultural diversity and heritage, GTA will arrange a Zulu Dance performance as part of the welcome experience.
- 4.3 To deliver a seamless and professional reception, GTA requires a service provider to manage the performance, transport logistics, catering for the performing group, and associated payments.

5. DELIVERABLES/SPECIFICATIONS

- 5.1 The service provider will be required to deliver the following:
 - Payment for the Zulu Dance Group for their performance
 - Professional Zulu dance performance lasting 45 minutes

- On-time pickup and drop-off logistics
- Safe transport for performers
- Catering for 10 performers
- On-site coordination with GTA representatives

- d) Service providers may ask for clarification via email on these terms of reference or any of their annexures up to 48 hours before the deadline for the submission of the bids.
- e) Any request for clarification must be submitted by email at Bids@gauteng.net and answers will be emailed to all service providers that require any clarity.
- f) The GTA reserves the right **NOT** to make an appointment for this project.
- g) The cost of preparing and submitting bids by prospective suppliers will be at the cost of the prospective supplier.
- h) The validity of the received bids shall be ninety (90) days.
- i) The awarded service provide may be required to sign a service level agreement with the GTA.
