## **1. INVITATION**

- 1.1 The Gauteng Tourism Authority (GTA) hereby invites suitable service providers to submit a formal quotation for the Job Grading and Job Evaluation of Eighteen (18) GTA positions.

## **2. BACKGROUND**

- 2.1 The Gauteng Tourism Authority was established through the Amendment Act, No. 3 of 2006, and came into effect on 7 June 2006. The Amendment Act provides among others, GTA's policies revision, and that a Board of Directors be established as the accounting authority. In accordance with the Gauteng Tourism Act in section 4, the GTA is enjoined with amongst other, the following powers and duties:

- To promote, foster and develop tourism in the province.
- To encourage the sustainable development, provision, and improvement of tourist amenities.
- To establish guidelines for tourism development.
- To initiate and implement activities and actions nationally and internationally intended to attract tourists to the province.

## **3. OBJECTIVES**

- 3.1 To invite prospective service providers to submit a proposal for the appointment to conduct Job evaluation using Paterson Grading Methodology.

## **4. SCOPE OF WORK / DELIVERABLES**

The service provider will be required to perform the following activities:

- 4.1 The service provider is required to grade (18) positions on the newly approved Organisational Structure of GTA.
- 4.2 Undertaking a thorough Job analysis of each position.
- 4.3 Engage with the Job holders and line managers to confirm the Job contents, levels and reporting lines.
- 4.4 Evaluate and grade positions based on the approved Job profiles.
- 4.5 Conduct Job grading according to the Paterson Grading System.
- 4.6 Provide GTA with a report that sets out the methodology that was followed, the recommended grade and motivation for the recommendation.
- 4.7 Present the grading results to relevant structures as requested.
- 4.8 Attend to dispute resolution if any arose following the grading results.

## **5. MANDATORY ADMINISTRATIVE COMPLIANCE DOCUMENT**

- 5.1 The service provider must submit a minimum of two (2) Traceable Reference Letters from Government departments or Government Agencies for similar work completed. The letters must be on the company letterhead, signed and dated with contactable details.

**6. DURATION OF THE PROJECT**

6.1 The duration of the project is one (1) month after the appointment of the service provider.

**N.B:** Bidder must furnish the GTA with a detailed quotation / financial proposal inclusive of all costs against the above-mentioned deliverables for the provision of the Job Grading and Job Evaluation of Eighteen (18) GTA positions.

**Failure to provide a quotation as required above may result in the disqualification of the bid.**

**7. FORMAL PRICE QUOTATION**

7.1 The formal all-inclusive quotation (**Inclusive of VAT**) should indicate the total costs that will be charged for the execution of the project.

**10. CRITERIA FOR EVALUATION OF PROPOSALS**

10.1 Criteria for evaluation are as follows:

- a) The service provider will be appointed in terms of the Preferential Procurement Regulations (2022).
- b) The proposal will be evaluated using the 80/20 preferential system wherein 80 represents price and 20 for specific goals.

- c) The GTA reserves the right not to appoint any service provider if the received proposals do not match its requirements.
- d) Service providers may ask for clarification via email on these terms of reference or any of its annexures up to 48 hours before the deadline for the submission of the bids.

- f) The GTA reserves the right **NOT** to make an appointment for this project.

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1.1 The following preference point systems are applicable to invitations to tender:

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes

of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
