## **1. INTRODUCTION**

- 1.1 The Gauteng Tourism Authority continues to position Gauteng as a leading business tourism destination, particularly within key economic hubs such as Rosebank. With the province hosting numerous conferences and business events annually, there is a growing opportunity to integrate leisure experiences into business travel.
- 1.2 A group of 40 researchers will be attending a conference in Rosebank, The Capital Hotel, presenting a strategic opportunity to align with the Gauteng Winter Campaign and promote the province's tourism offerings to a high-value, knowledge-driven audience.
- 1.3 This will provide an opportunity to leverage their presence in Gauteng by introducing them to the province's diverse tourism experiences beyond the conference environment. This initiative supports the broader campaign narrative of BLEisure (Business and Leisure) experiences.
- 1.4 It further aims to demonstrate how Gauteng seamlessly blends business with lifestyle, encouraging delegates to extend their stay and engage with local attractions.

## **2. INVITATION**

- 2.1 This Request for Quotation (RFQ) is an invitation by Gauteng Tourism Authority to assist in hosting Research Conference Delegation for a Soweto Experience on the 28<sup>th</sup> of May 2026.

## **3. BACKGROUND**

- 3.1 Hosting the 40 researchers presents a high-impact opportunity to directly engage a captive audience already present in the province coming from other provinces for business purposes. By curating a tailored tourism experience, Gauteng Tourism Authority can:
  - Convert business travellers into leisure tourists.
  - Enhance delegate satisfaction and overall destination perception.
  - Generate positive word-of-mouth and potential future visitation.
  - Maximise return on investment from existing business tourism traffic.
- 3.2 In light of the above, this initiative represents a strategic and high-value opportunity for the Gauteng Tourism Authority to maximise the impact of an existing business event by converting conference delegates into experiential ambassadors for the destination. By seamlessly integrating curated tourism experiences into their stay in Rosebank, we not only enhance delegate satisfaction but also advance our Winter Campaign and reinforce Gauteng's positioning as a destination where business and lifestyle intersect.

3.3 Importantly, this hosting supports the growth of domestic tourism, stimulates local economic activity, and promotes small and medium tourism enterprises across the province. Through this tour the GTA will enable Gauteng Tourism Authority to deliver a memorable, well-coordinated experience that embodies our campaign promise: “Where business meets leisure experiences, Blesure!”

**3.4 The Appointed Service Provider needs to assist to organise and host this delegation who come from different provinces to attend a conference in Gauteng.**

4.1 In line with the tourism sector recovery plan, the GGT2030 implementation plan, the GTA needs to achieve the following pre-determined objectives:

- To showcase Gauteng’s cultural, culinary, and heritage experiences to domestic market consisting of government employees from different provinces.
- To encourage extended stays and increased tourism within the province.
- To strengthen Gauteng’s brand visibility among influential researchers and professionals.
- To create memorable, shareable experiences that amplify the Winter Campaign messaging.

**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

**1.2 To be completed by the organ of state**

- a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

**1.4 To be completed by the organ of state:**

The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms

of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left( 1 + \frac{Pt - Pmax}{Pmax} \right) \text{ or } Ps = 90 \left( 1 + \frac{Pt - Pmax}{Pmax} \right)$$

- Ps = Points scored for price of tender under consideration  
Pt = Price of tender under consideration  
Pmax = Price of highest acceptable tender

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
